TRANSACTION IN OWN SHARES

Avation PLC (LSE: AVAP, Avation or “the Company”), the commercial passenger aircraft leasing company announces that on 22 July 2026 it repurchased 10,000 ordinary shares through the market at a price of 135 pence per share. The repurchased shares will be held in treasury.

Following the repurchase there are 61,425,369 ordinary shares in issue with 1,610,068 held in treasury. Total voting rights are now 59,815,301.

This transaction is conducted pursuant to Avation’s approved share buyback programme, which authorises the repurchase of up to 25% of its issued share capital, under a mandate approved at the annual general meeting in late November 2025. The authority allows Avation to buy shares in the market within specified price limits until the conclusion of its next annual general meeting.
